

Terms and Conditions of Rental

TERMS AND CONDITIONS OF STANDARD RENTAL AGREEMENT

Additional Driver

Additional driver's charge is SID 40.00 (+GST) per rental and per additional driver.

Age

The minimum age is 23 years and the maximum is 74 years for all car groups.

Breakdown

A 24-hour breakdown coverage service is provided. Procedures advised at vehicle pick-up.

LDW (taxable)

LDW reduces the renter's financial responsibility from full replacement value of the car and loss of use to the insurance excess (see non-waivable excess) in case of damages to the rented vehicle regardless of fault.

LDW does not cover missing items, vandalism, riots or damages caused other than as a result of a collision.

Cross Border Rentals (taxable)

Vehicle rented in Singapore can be driven into Malaysia with a daily fee of SID 40.00 (+GST) per day. Driving a rented vehicle into Thailand is not permitted.

Note: customer needs to request a cross border rental at the time of reservations (remark: driver Malaysia).

Cash is not acceptable as a method of payment for rentals going abroad.

Currency Information

Singapore dollars: SID
Currency restrictions: none.

Driver's License

Applicable to all drivers: a full qualified driving licence is required and must have been held for a minimum of one year to be eligible to drive a Budget vehicle in Singapore.

International driver's licence: an international driver's licence is required (issued in drivers' home country) for licences printed in a non-Roman alphabet.

Fleet Comment

Models noted below are representatively only. All car groups and models may not be available at all locations.

Gas

Refuelling charge is N/A.

Unleaded cost per litre: SID 3.50 (+GST)

Meet late arrival

A Meet Late Arrival service is provided at Changi Airport terminal 1, terminal 2 and terminal 3 only. Meet late arrival surcharge of SID 100.00 (+ GST) is applicable. Full customer details must be given including CID and CEX. No show fee of SID 100.00 (+GST) will apply.

Method of Payment

American Express, Diners Club, MasterCard, Visa, Budget voucher/ charge card, Visa and Master debit cards will only be accepted at check-in/return of Budget vehicle.

Payment by personal cheque and cash rentals are not available.

Motor Liability Insurance

In accordance with insurance laws this is compulsory. Motor liability insurance covers SID 5,000,000 for third party property damage and unlimited coverage of personal injury to third party and passengers (excluding driver).

NWE

STANDARD NON WAIVERABLE EXCESS FOR LDW:

GROUP C/D = SID 1500.00

GROUP F = SID 2500.00

GROUP L/W = SID 3000.00

WDW (Windscreen Damage Waiver) is available at SID 5.00 (+GST) per day to remove all excess for damage to the front windscreen and windows.

Special Equipment

Baby and infant seats: below the height of 1.35m are required to use a child safety / child booster seat by law. Baby seats are available on request. Rental fee is SID 10.00 (+GST) per day with a maximum rental fee of SID 100.00 (+GST) per rental.

GPS: mobile GPS (Garmin) navigation units are available for all car groups. To reserve enter /GPS in the remarks field. The maximum rental fee is SID 120.00 (+GST) per rental. Available at all locations in Singapore (subject to availability).

Rental conditions (rates exclude GST): Daily rate is SID 12.00 per day (+GST), weekly rate is SID 84.00 (+GST) and the price for GPS is capped at 10 days.

Surcharges

Electronic Road Pricing (ERP):

Congestion charging is applicable in Singapore. A cashcard is required for cars that drive through an ERP gantry. All Budget vehicles are fitted with an In-Vehicle Unit (IU) that the cashcard is inserted.

Each time a car drives through an ERP gantry the fee will automatically be deducted. Cashcards can be purchased from Budget at a cost of SID 30.00 (+GST) They can also be purchased from most petrol station and 7-eleven stores.

A cashcard is also required to pay the toll when crossing the causeway into Malaysia and for most parking facilities in Singapore.

A touch-n-go card is also required to pay the toll fee when driving into Malaysia and can be purchased from Budget at a cost of SID 25.00 (+GST).

Traffic fines: administration fee of SID 50.00 (+GST) will be imposed for traffic fines processed.

Tax

7 % GST (goods and service tax) applicable on all items.
